5. **DO NOT USE SELECTION RATING SOFTWARE THAT IS NOT LISTED IN THE AHRI DIRECTORY** ([AHRI Directory](#)) (Refer to [WCCL OM](#), Section 9.1.3)
6. **DO NOT INCORRECTLY USE AHRI CERTIFICATION MARKS (MARK)** (Refer to [AHRI Brand Usage Manual](#))
  - a. Generic Advertising – use this Mark and statement only with generic advertising (e.g. general product brochures & company home page) (Refer to page 10, [AHRI Brand Usage Manual](#)).
